## The Pastor's Pen:

Friends, I know this is an anxious time in our denomination. I want to keep you informed about what is happening. In the latter half of December, news was released that the Board of Trustees, at the direction of the Bishop, had come up with a plan for those wishing to disaffiliate with our denomination. This plan calls for a church to engage in a time of discernment before any action is taken. It also has certain financial stipulations. You can read more about it here: https://www.umcsc.org/discern/. This plan has no termination date and would be available to any church going forward. I will be sharing details of the plan with our Board of Stewards.

While others are rushing, I am encouraging us to be deliberate. One reason is that the Global Methodist Church has not yet been organized through its convening General Conference. Not long ago, I submitted a letter to the editor of The Advocate, the newspaper for SC Methodism. It read:

This is NOT a letter for or against changing our Disciplinary language. This is NOT a letter for or against disaffiliation. It is a letter pondering the logic of disaffiliation NOW.

I am baffled by the number of churches who sought or are seeking disaffiliation right now. At this point nothing has changed. General Conference is more than a year away. Ironically, as conservative churches disaffiliate, the likelihood of the language changing increases. By leaving the denomination, they are potentially precipitating the very action they claim to oppose.

What happens in the event that the language doesn't change? What will those who have rushed to disaffiliate do then?

Also, my father used to caution against buying a car that was in its first model year. "Let them work out the kinks," he used to say. If you disaffiliate now, what are you going to join? Might it not be better to wait and let a new denomination "work out the kinks" before joining?

For the sake of argument, let's play a little game of "what if?" What if on May 2, 2024 (the last Thursday of General Conference) the vote to change the language of TBOD passed? What would be the effect of St. Anywhere UMC on May 5th? What would change? NOTHING!!! The same congregation who loves and cares for each other would gather to worship God together, listen to their beloved choir, and hear a sermon preached by the same pastor who was there the week before, and the week before that, etc.

"But, Jeremy, our BOD would have changed." Actually, no. Changes to The Book of Discipline do not take effect until January 1st of the following year.

"We might suddenly be overrun by members of the LGBTQ community!" Really? Do you think that after more than 30 years of publicly squabbling over this issue and denouncing homosexuality, that merely changing our language is going to convey a change in attitude and acceptance? I have spoken to several members of the LGBTQ community who tell me that they do not think a change in our denominational language will indicate to them a change in attitudes in local churches and they won't be visiting a UMC any time soon, no matter what happens at GC2024.

"I just can't stand the thought of a gay wedding in our sanctuary!" The BOD gives the sole discretion concerning weddings to the pastor, including heterosexual unions. There have been occasions when I would have refused to conduct a wedding had the couple not come to the realization that they should not get married. Other occasions when, because of elements the couple wanted in their wedding ceremony, I steered them to a venue other than the church. Should the language change, I would hope that a wise pastor would consider the prevailing sentiment in his or her congregation and make appropriate decisions regarding weddings and venues.

"What if we get a gay pastor? "What are the odds of that happening? Supposing that we continue to ordain elders as we have the last 3 years (just under 9 a year) and that an average number are gay (current figures are at about 7%) and we do that for the next 30 years, your odds in 2055 would be about 1 in 37. Most people will only experience about 20 pastors in their lifetime. So, a child born in 2025 would have to live almost 2 lifetimes to have a gay pastor in South Carolina. Furthermore, as the Bishops and Cabinets of the past have been very careful in making cross-racial appointments, I think they would ponder long and hard before appointing a gay pastor to a particular church. Can we, as good Methodists, apply some Reason and Experience in addition to Scripture and Tradition?

So, my friends, let us be calm. Let us look to our Board of Stewards for guidance. As I sit here writing this, I just looked over and saw a bulletin. Looking at it, I realize the words "Saint Paul" are about 5 times bigger than "United Methodist Church." I hope that is true. I hope that our love and concern for one another as a congregation is far greater than the wrangling of our denomination.
